Billing & Fees:

Prahran Market Clinic is a private billing clinic. Telehealth appointments are billed in the same manner as in person appointments. Fees are payable at the time of consultation by cash, Mastercard, Visa, or EFTPOS.

Bulk billing is **not** guaranteed and is available only at the doctor's discretion. We can offer instant Medicare rebates for in person appointments/payments, you will need a debit card for this option. Over the phone payments, can be claimed automatically using Medicare online for automatic claiming if payment is made on the day.
